Fruit and Flower Paintings by modern artists constitute the new exhibition which The Museum of Modern Art, 11 West 53d Street,

New York, will open to the public on Wednesday, March 15th. This show will occupy the fourth floor galleries of the Museum. The Retrospective Exhibition of the Works of Maurice Sterne will continue on the first three floors until March 25th.

The paintings shown include the works of the early masters of modern art: Cezanne, Monet, Manet, Redon, van Gogh, Renoir, Rousseau, and others. Among the living artists included are Brook, Karfiol, Sheeler, Goldthwaite, Matisse, Demuth, Biddle, Burchfield, Kantor, Kuniyoshi, Speicher, Fiene, and O'Keeffe. American and foreign artists will be about equally represented.

One feature of the exhibition will be the display in the Permanent Architecture Room, which is on this floor, of the use of flower and plant arrangements in modern architecture. This supplementary exhibition will be arranged by Mr. Philip Johnson, Chairman of the De-

partment of Architecture of the Museum.
