Dear Neighbors,

Over the next several months the empty lot west of the Museum on the south-side of 54th Street will be used in preparation of *Richard Serra Sculpture: Forty Years* exhibition that opens on June 3, 2007.

The exhibition presents works from the artist's forty-year career, from his early years experimenting with materials such as rubber, neon, and lead, to monumental recent pieces including *Intersection II* (1992) and *Torqued Ellipse IV* (1999), along with three new works that have never been seen exhibited before.

The logistics of installing these mammoth-scale pieces requires a crane that allows riggers to truck heavy material and equipment into the lot. This process requires meticulous planning before the pieces are ultimately installed in the Sculpture Garden and in MoMA's galleries.

On Tuesday, March 20 a crane will be used to hoist steel plates, large steel containers, and other materials in the lot. A large platform will be constructed to house most of the equipment. This work will be done between the hours of 7:00 a.m. and 6:00 p.m. The platform will remain in the lot until early October.

Please keep in mind that certain equipment may call for the use of a trailer and therefore will require limited access to the street. We will notify you in advance of this occurring.

As an update on the progress of the West End property that MoMA sold earlier this year to Hines, the international real estate development firm, we want to let you know that tomorrow's *New York Times* will include an article by Nicolai Ouroussoff announcing that architect Jean Nouvel has been selected by Hines to design the building. We are delighted with the selection of Nouvel and believe his exceptional design will create a major architectural addition to New York and will significantly enhance the character of the block.

Selling the land adjacent to MoMA has allowed us to accomplish multiple goals: strengthening the endowment in order to provide additional support for our exhibition program, and increasing gallery space for the permanent collection. This new building will provide MoMA with 50,000 gross square feet of new space, directly connected to the existing galleries on the 2nd, 4th, and 5th floors. MoMA expects to continue to work with the New York-based architectural firm Kohn Pedersen Fox (KPF) on the design of its interior space. The time frame of the project will be established by Hines and will likely take a number of years.
