WHAT DOES IT TAKE TO STOP THE WAR?

There's a war going on—a world war. A war against poor people, black people, working people. Today the main battle ground in that war is Vietnam. Tomorrow it will be in Laos; and the day after that, Brazil, or South Africa, or Harlem. It's all the same war—because it's all caused by the same system.

That system has a name: IMPERIALISM. It's all the same system because it's all run by the same people—rich Americans. Check it out for yourself: a few rich Americans—one half of one percent of the American population, to be exact—own 80% of all the corporate stock in this country. They also own most of the wealth and natural resources of the entire non-Communist world. Most important of all, they own the US government. They use that government to force people to work for them; and when people fight back, they use that government to make war on people.

Right here in this country, the US government makes war on people every day. It's making war on the Black Panther Party—for protecting black people against the racist cops who occupy their community. It's making war on Gls—for refusing to do its dirty work in Vietnam. And it's making war on everybody—black, Latin and white—who's tired of getting shoved around.

What does it take to stop this war? The Vietnamese have shown us what it takes. They are stopping the war in Vietnam—by winning it! They're stopping the war by fighting a war of their own. A people's war. And that's what it takes.

IT TAKES A WAR TO STOP A WAR!

There are lots of ways to fight a war. Before you can fight with guns, you have to learn how to get yourself together, how to stand up to the man, how to show your anger. That's how the Vietnamese started to fight a long time ago: and that's how we're going to start right now.

We've got plenty of anger to show. We're angry about the war against the Vietnamese, the war against black people; and we're also angry about the war against us. We're angry about psychological warfare—that's the brainwashing they give us in the schools and on TV. We're angry about the way they track us—women into the kitchen, men into the army, everybody into bull shit jobs just to make more money for them. When they put GIs in the stockade, it gets us mad; and when they gag and bind Bobby Seale of the Panthers in a public courtroom, it gets us even madder.

So we're going to show our anger. On Thursday, Nov. 13, we're going to go down to Foley Square. Foley Square: that's where the draft headquarters are; that's where the courts are. The draft and the courts: two weapons in the same war.

Then we're going to Washington to march against the war; and we're also going to march on the "Justice" Department—the domestic Pentagon. And one week later we're going up to Connecticut to march on the prison where 5 Panther women—3 of them pregnant—are being tortured.

And everywhere we go we'll be saying the same thing.



We'll be saying: SUPPORT THE PRG--U.S. OUT OF VIETNAM NOW

And we'll be saying: Free Huey . 'ewton! Free Bobby Seale! Free Martin Sostre! Free Los Siete de la Raza! Free the Panther women! Free the Conspiracy 8! FREE ALL POLITICAL PRISONERS. NOW!

And what we'll be doing is rising up angry-angry enough to stop a war.

Flash: Nixon declares war on Panthers. Local police jail and murder Panther leaders; food for free breakfast program destroyed. (Meanwhile, NY State announces welfare cuts- $66\dot{q}$ a day for food). In San Francisco, 7 Mexican-Americans framed for murder. Their real crime: organizing the Latin community.



Flash: hearings reveal that US troops are already fighting "secret war" in Laos, Cambodia, Thailand. Meanwhile, Jolly Green Giant opens new plantation in Formosa. High school tracking system works overtime—sends black, Latin and white youth to fight and die in Southeast Asia.



While US firms sell napalm to drop on striking Bolivian miners, Green Berets sent to hunt down Che. (US companies own every major bank in Latin America, 90% of all Venezuelan oil.) Troops sent to Dominican Republic: United Fruit stock goes up.






