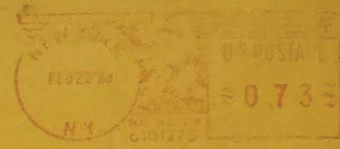

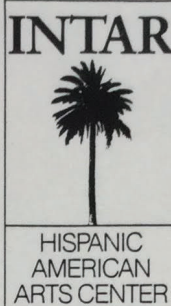

Opening Reception Tuesday March 1, 1988 From 5 - 7 p.m.

INTAR Gallery will present an exhibition of new works by artist Felix Gonzalez-Torres. The exhibition opens March 1 and continues through April 8, 1988. A reception for the artist will be held on March 1 from 5 - 7 p.m. at INTAR Gallery 420 West 42nd St., New York, New York.

Gonzalez-Torres has, throughout his career, incorporated objects with social commentaries on current political issues.

In this exhibition of new works at INTAR Gallery, Gonzalez-Torres uses text and three-dimensional objects to examine the means by which institutions shape relationships and set the parameters of reality. As Gonzalez-Torres states, the exhibition focuses on "culture's inability to assimilate certain things that results in a virus of paranoia and displacement". He continues, "The exhibition is a result of my reaction to social and political events and my efforts to comprehend the abstraction of the facts suggested by those events."

Gonzalez-Torres has exhibited in the United States, Germany, France and Puerto Rico. He has been a member of numerous group shows including last year's Corporate Crimes installation at Media Gallery in San Francisco and Selections, an installation at New York's Artists Space. In addition to his new exhibition at INTAR Gallery, Gonzalez-Torres is participating in the group exhibition Language Does Not Explain opening March 3, 1988 at the Stux Gallery in Boston.
