Under these circumstances we cannot accept responsibility for this insurance and I would suggest that you take the matter up with Paul Rosenberg & Co. who authorized the placing of the insurance.

Meanwhile, since we have no connection or dealings with Paul Rosenberg, I am sending a copy of this letter to our customer so that he can take whatever steps he thinks necessary with Paul Rosenberg & Co. to assist you in getting this matter straightened out.

"Every employer shall keep a record of all injuries, fatal or otherwise, received by his employees in the course of their employment. Within ten days after the occurrence of an accident resulting in personal injury, which shall cause a loss of time beyond the day of working shift on which the accident occurred, or which shall require medical treatment beyond ordinary first aid, a report thereof shall be made in writing by the employer to the Commissioner upon blanks to be procured from the Commissioner for that purpose. Such report shall state the name and nature of the business of the employer, the location of his establishment or place of work, the name, address and occupation of the injured employee, the time, nature and cause of the injury and such other information as may be required by the Commissioner. An employer shall furnish a report of any other accident resulting in an injury received by an employee in the course of his employment or an occupational disease incurred by an employee in the course of his employment whenever directed by the Commissioner. An employer who refuses or neglects to make a report as required by this section shall be guilty of a misdemeanor, punishable by a fine of not more than five hundred dollars."

#### Section 13.

"The employer shall promptly provide for an injured employee such medical, surgical or other attendance or treatment, nurse and hospital service, medicine, crutches and apparatus for such period as the nature of the injury or the process of recovery may require. If the employer fail to provide the same after request by the injured employee such injured employee may do so at the expense of the employer." \* \* \* \*

#### Section 52

"Failure to secure the payment of compensation shall constitute a misdemeanor, punishable by a fine of not more than five hundred dollars or imprisonment for not more than one year, or both. Where the employer is a corporation the president, secretary and treasurer thereof shall be liable for failure to secure the payment of compensation under this section."

"All fines imposed under this chapter, except as herein otherwise provided, shall be paid directly and immediately by the officer collecting the same to the Industrial Commissioner for the benefit of the special fund created under subdivision eight of section fifteen of this chapter." \* \* \* \*

#### Section 51.

"Every employer who has complied with section fifty of this chapter shall post and maintain in a conspicuous place or places in and about his place or places of business typewritten or printed notices in form prescribed by the Commissioner, stating the fact that he has complied with all the rules and regulations of the Department and that he has secured the payment of compensation to his employees and their dependents in accordance with the provisions of this chapter." \* \* \* \*
