



However, I have no knowledge of what arrangement he made with Paul Rosenberg & Co. for the loan of the paintings but it is my assumption that in that arrangement our customer covered the matter of insurance.

Under these circumstances we cannot accept responsibility for this insurance and I would suggest that you take the matter up with Paul Rosenberg & Co. who authorized the placing of the insurance.

Meanwhile, since we have no connection or dealings with Paul Rosenberg, I am sending a copy of this letter to our customer so that he can take whatever steps he thinks necessary with Paul Rosenberg & Co. to assist you in getting this matter straightened out.
